1 - 4. CALL TO ORDER, ROLL CALL, INVOCATION, AND PLEDGE OF ALLEGIANCE (8:28:39) - Mayor Crowell called the meeting to order at 8:28 a.m. Ms. Merriwether called the roll; a quorum was present. Good Shepherd Wesleyan Church Pastor Nick Emery provided the invocation. At Mayor Crowell's request, Planning Manager Susan Pansky led the pledge of allegiance.

5. PUBLIC COMMENT (8:29:59) - Mayor Crowell entertained public comment. (8:30:14) Fire Chief / Emergency Manager Bob Schreihans thanked the Board members for participating in FireOps 101. He announced the Great Shakeout scheduled for 10:15 a.m., and advised that he would leave informational material on the back table of the meeting room. Mayor Crowell commended Fire Department personnel on their recent assistance with a water leak at a local residence.

Mayor Crowell entertained additional public comment. (8:32:56) In reference to recent leadership changes, Nevada Humane Society Interim CEO Denise Stevens assured the Board that the Nevada Humane Society's commitment to the community "remains firm." She commended the Public Works Department staff. Mayor Crowell entertained additional public comment; however, none was forthcoming.

STATUS REPORTS AND COMMENTS FROM BOARD MEMBERS (9:54:03) - Supervisor Shirk advised of having participated in meetings with City staff “on the noise and the RV ordinances.” He further advised of a public meeting, scheduled for Tuesday, October 20th in the Community Center Bonanza Room, “seeking public input on the survey of the Regional Transportation Plan.” He expressed the opinion that #CarsonProud “is something that could be expedited in a more beneficial ... benefit to the community ...” He suggested reviewing the protocol for advising the Board members of community emergencies. He advised that the legislative appointments to the Charter Review Committee have yet to be filled.
